The Wheeler Memorial Library is a Carnegie-style building of 7,956 square feet, constructed in 1914. The two-story structure consists of a main floor that is several feet above ground level, a basement, and an attic with a mezzanine area. The attic is unfinished and unsafe for public use; the mezzanine is only accessible through the attic. (The attic and mezzanine were not counted in the building program or ARIS.) No part of the library is ADA-compliant. The building has not been significantly renovated since its original construction. The renovation would increase the square footage to 20,062 square feet, and would make the entire building accessible.

The current estimated population of Orange is 7,756; the estimate for 2035 is 8,750, with the number of residents aged 65-85+ increasing by 78.5%. With such a dramatic increase predicted for senior residents, accessibility becomes an ever more pressing need for the library. The key features of the renovation include a ground-floor entrance and circulation area and an elevator to facilitate access to other areas of the library. Other notable features include:

- A community meeting room that will be accessible to the community after hours
- A conference room and two quiet study rooms
- A young adult room
- A second floor devoted solely to the children's room
- A staff room with a staff bathroom
- Three public restrooms, two of which will be on the ground floor
